Thank you for registering with California Department of Food and Agriculture State Organic Program (SOP). Your application has been approved and enclosed is a certificate for proof of registration.

The SOP is responsible for enforcing the federal Organic Food and Production Act of 1990 and the California Organic Food and Farming Act. All persons engaged in the production or handling of agricultural commodities sold, labeled, or represented as organic must comply with Title 7 of the Code of Federal Regulations Section 205 et seq. and Food and Agricultural Code (FAC) Section 46000 et seq.

An inspection with review of records is **required** for operations registering for the first time with the SOP, to verify the registration information provided in the application. Newly registered operations will be contacted at a future date to schedule an inspection. Operations renewing their registrations with the SOP may also be subject to inspections. **Please note:** Every operation is required to provide records within 72 hours of the request and submit to an inspection as requested by the SOP; authorized under FAC 46029(a). Spot inspections are authorized under FAC 46018.1.

A registrant **must notify the SOP** of any change in the information listed on their Organic Registration Certificate within 14 days of the change, or prior to the sale of any additional products. An amendment is required when an operation has one or more of the following changes to their registration:

- Addition of new facilities or growing locations
- Change of ownership
- Addition of production acreage
- Change/addition of operation type(s).
